After two years apart, the International Emissions Trading Association (IETA), the International Carbon Action Partnership (ICAP) and all the supporting organisations look forward to welcoming delegates to our flagship **North America Climate Summit (NCAS) 2022** on **20-22 September**, an official accredited event part of the Climate Week New York City 2022 & UN General Assembly.
